## Terms And Conditions for Sale Vehicles

2. Interested Parties may take part in Open Auction for sale of **SWARAJ MAZDA TRUCK NO. HP19-A 8525** as mentioned in auction at 1:00 PM on 07-03-2025
3. The Auction of **SWARAJ MAZDA TRUCK NO. HP19-A 8525** shall be strictly on "**As is Where is Basis**" and no guarantee or certificate of its worthiness or quality will be given by the Department. The condition of the vehicle can be inspected physically between 28-02-2025 to 05-03-2025 at **BABA SHRI MAI DASS SADAN**.
4. The intending auctioneer should submit earnest money for Rs. 40,000/- (Forty Thousand Rupees Only) in the form of Bank Draft in favour of Temple Officer Mata Shri Chintpurni Ji or can be deposited in cash before participating in Auction process. The bank draft should be deposited before participating failing which the quotation shall not be considered at all. If the highest bidder/successful bidder fails to deposit the sale price within 03 days time positively, his earnest money will be forfeited. In case the offer is withdrawn by the bidder, the Earnest money deposited by him shall also be forfeited.

8. The Successful bidder (s) will also be responsible for getting the Registration Certificate of the vehicle (s) transferred in the name of respective bidder at his own cost expeditiously. This office will not be responsible for any lapse on his part in this regard.



9. The Commissioner (Temple) Mata Shri Chitnpurni Ji reserves the right to reject all or any tender in whole or part without assigning any reason thereof.
10. EMD of unsuccessful bidder shall be returned within three weeks of auction of the vehicles.
11. The bidder are required to reveal their full name/name of the authorized signatory of the firm/name of father, full postal address, telephone number & mobile number.
12. Disputes, if any, shall be subject to Jurisdiction in the Court of **AMB** only.
13. If the highest quoting firm fails to honor the bid; the bid will be cancelled & its EMD forfeited. In such an event, an opportunity shall be given to the next highest quoting eligible bidder (H-2 quoting party) to complete the bid provided it is prepared to accept the prices offered by the H-1 party. In case of any dispute, decision of the Commissioner (T)-Cum- Deputy Commissioner Una shall be final.
