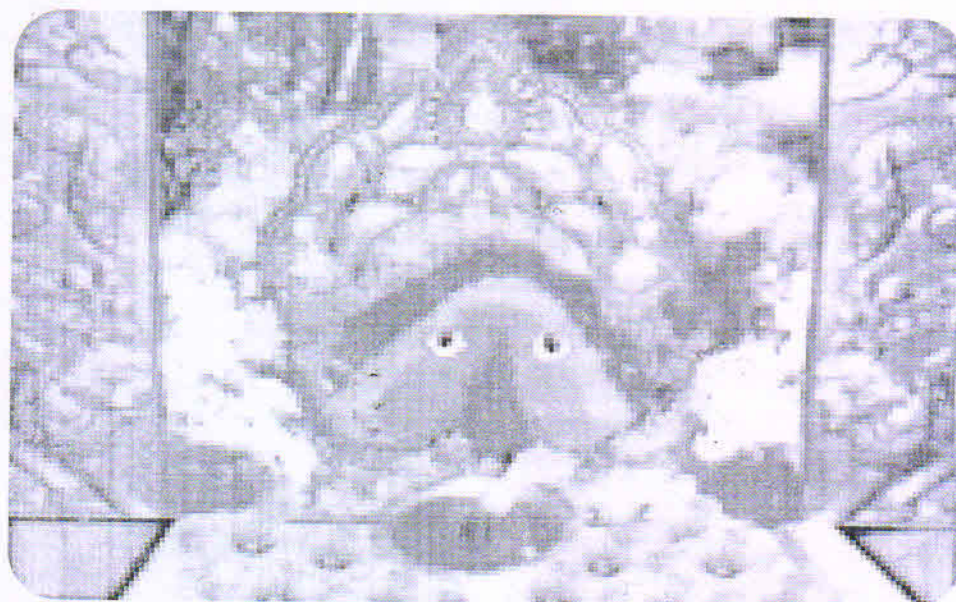





The tender document can be obtained from Office of Temple Officer Mata Shri Chintpurni ji against submission of cash/bank draft Rs.500/- (Non refundable) of any commercial bank in the name of the Temple Officer payable at Chintpurni ji. The Tender document may also be downloaded from the official website of Temple www.matashrichintpurni.com and Tender document charges should be sent in the form of bank draft of Rs. 500/- (Non refundable) of any scheduled bank in the name of the Temple Officer, Temple Chintpurni payable at Chintpurni,ji along with Earnest Money Deposit (EMD) Of Rs.5,00,000/- (rupees two lakh only)- in the form of DD in Favor of Temple Officer Temple Trust Mata Shri Chintpurni ji payable at Chintpurni otherwise application shall not be considered. The Tender document/form are not transferable Tender document may be obtained with effect from 06-07-2024. The Tender with particulars and enclosures must reach the Officer of Temple Officer Mata Shri Chintpurni,ji up to 05:00 pm. on 30-07-2024. For and on behalf of Commissioner (Temple) Mata Shri Chintpurni ji tender under two bids system are invited through Temple Trust Mata Shri Chintpurni Ji from reputed professional company/firm / authorized supplier dealing in packing of pasteurized dry fruits for supply of Panch Mewa Prasad Pouch to Mata Shri Chintpurni ji initially for a period of three years extendable for another two years as per the detail given below.

1. SCOPE OF WORK:-

1. The selected bidder shall be required to arrange all the required raw material items of Panch Mewa Prasad in bulk, setting up and operationalization of the Packing Unit and production of Pouch Prasad for the Temple Trust sale outlets. The Packing Unit has to be set up at the premises allocated by Temple Trust Mata Shri Chintpurni Ji .
- B. Location for three sale outlets (min.100 Sq ft for each outlet) shall be provided by the Temple Trust initially and the selected bidder shall develop and operate all three outlets at its own cost. The sale outlets shall be located in the main temple premises, Near Entrance of Mai Dass Sadan Building and at another location selected by the Temple Trust .
- C. **The Selected bidder will not replicate/sell use the Specifically designed and approved Panch Mewa Prasad Packings in open market. In case he replicate/ sells the packings in open market etc., then his tender will be cancelled leading to forfeiture of Performance Security and firm shall be Blacklisted. The Tentative quantity of Panch Mewa Prasad Pouches units for next month shall be got approved by the Temple Authorities before 20th of every month.**
- D. The Official Prasad shall be available in different packings starting from Rs.100. The official Prasad Packings may consist of a mix of dry fruits, AamPapad, Religious Threads, Khajana coins, mishri, chuni,etc. Each pack design and contents shall be approved by the Temple Trust before production for sale.
- e. Any edible items in the Prasad packings shall adhere to the standards and should have a shelf life of at least 30 days.
- f. The selected bidder shall have the exclusive right to market and sale of official Prasad of Mata Chintpurni Temple for the entire duration of the contract through both online and offline modes.

- g. The selected bidder must have the technical expertise to ensure best hygiene standards for packing and supplying of the Prasad. The Temple Trust shall be at liberty to go for any number of quality checks from any independent recognized lab at any point of time during the currency of contract with the selected bidder.
- h. SOP for supply and production of Prasad process to be formulated by the selected bidder firm with complete flowchart in consonance with Temple Trust needs, which shall become part of the agreement deed.
- i. The selected bidder shall be required to purchase and install all required Plant & Machinery with all related fixed assets as per best industry standards for trouble free running entirely at its own cost after approval of the Temple Trust Mata Shri Chintpurni Ji.
- j. The cost of Electricity, Water, Cleanliness, Hygiene and Pest Control etc. required for operationalization of Packing Unit and Sale Outlets shall lie in the scope of the approved bidder. The Temple shall provide the required services and the selected bidder shall be required to pay monthly bills as per the consumption bills raised by the Temple Trust.
- k. The Processing Unit and sale outlets shall have to be made operational within a period of 120 days from issuance of LOA.

2. The Panch Mewa Prasad shall comprise a mix of 05 dry fruits (duly Pasteurized)- Almonds – 5 gms. Cashews -5 gm., Raisin 7- gm Dry Dates 10-gm (Diced) and Dry Coconut- 8 gm (Diced) as per specifications mentioned in Annexure "C" to be packed in Consumer Packs of 35 gm each.

3. All the ingredients must be pasteurized processed with FIVE LOGS Pathogen Reduction working on "IR Heating & UV Cooling in controlled atmosphere to ensure that the dry fruits are crispier, healthier and without any loss of aroma taste or nutritional value. The above stated essential process is further expounded as under;

- The dry fruits should be passed through 08 Closed Zones IR Unit in continuous Process which ensures Instant Core Heating of the Product killing the Bacteria by **Denaturing their DNA** that cannot withstand such instant heating
- The Process of instant Heating (IR) should be used to the core of the Dry fruits and hot Heating by Conduction Process which don't alters the Aroma and Taste of the Product as also is Nutrition value, The objective of the IR Heating shall be to keep the 'Aroma and Taste' of ingredients

unchanged thereby ensuring that the end-product crispier as an additional corollary

- The dry fruits should be then passed through UV Unit which cools the products and exposing bacterial to shock (From Heating to Cooling) and UV rays making the process of microbe annihilation more effective
 - The dry fruits should be then Packed and Sealed in an appropriate packing in a sealed environment in Modified Atmosphere Bulk Packs to avoid any Post Contamination
4. The dry fruits to be supplied should comply and confirm to FSSAI Standards. The selected bidder must have the technical expertise to ensure best hygiene standards and ensure pasteurized process and five log pathogen reduction before the dry fruits are packed and supplied. The Temple Trust shall be at liberty to go for any number of quality checks from any independent recognized lab at any point of time during the currency of contract with the selected bidder.
 5. SOP for supply and production of Pouch Prasad process to be formulated by the selected bidder firm with complete flowchart in consonance with Temple Trust's needs, which shall become part of the agreement deed.
 6. The selected bidder shall be required to purchase and install complete Plant & Machinery including Automatic Packing Machine, Ancillary Equipment as per best industry standards for trouble free running entirely at its own cost as per list mentioned in Annexure "G"
 7. The contents and design of printing matter of the Prasad Pouch shall be approved by The Temple Trust Mata Shri Chintpurni Ji
 8. The cost of Electricity, Water, Cleanliness, Hygiene and Pest Control etc required for operationalization of Packing Unit shall lie in the scope of the approved bidder.
 9. **Glassine Paper with heat sealable Food Grade Paper of 50-60 micron of size 13cms X10cms** material shall be used for the packing of dry fruits in single Prasad Pouches of 35 gm each
 10. The Processing Unit shall have to be made operational within a period of 120 days from issuance of LOA.
 11. The Prasad Packing Unit shall remain in a state of readiness and must have a minimum uptime of 98% and shall operate in such a manner so as to ensure that

the requirement of the CTT is met on a continuous basis. The selected bidder shall have to meet the requirement of CTT conveyed from time to time and must supply required number of Prasad Packets within 48 hours from the receipt of demand.

12. In case of any breakdown of Plant, same shall have be repaired and operations restored within 72 hours
 13. The selected bidder shall be exclusively responsible for setting up the complete Packing Plant (at its own cost) along with all related fixed assets required for the purpose. Besides, the structural changes shall also have to be done by the selected firm at its own cost after approval of The Temple Trust Mata Shri Chintpurni Ji.
 14. All legal compliances/permissions for running the unit will be exclusively the responsibility of the selected bidder and the role of CTT shall only be limited to provide NOC for obtaining all such permissions. The unit has to be strictly in compliance with all the statutory requirement.

The Tenderers are required to submit their Bids (Technical as well as Financials on under 2 bids system as per detail given below.

- i) The Tender are to be submitted as per two bid system i.e.- Technical Bid and Financial Bid. The technical bid should contain the papers to fulfil all the eligibility criteria, certificate of experience, satisfactory performance certificate, undertakings as per instructions. Financial Bid should contain the percentage rates quoted payable to Temple Officer Chintpurni for Supply and Sale of Panch Mewa Parsad as per instructions given in the tender document. Both the bids should be submitted in two separate sealed envelopes super scribed as "Technical Bid for Supply and Sale of Panch Mewa Parsad Packings. and Financial Bid for Supply and Sale of Panch Mewa Parsad Packings . Both sealed envelopes should be put in a third sealed envelope and should be superscribed "Tender for Leasing Out Of Space For Supply and Sale of Panchmewa Parsad Packings. A. Technical Bid

- i) Non Refundable Tender Fee of Rs 500/- (Rupees Five Thousand Only) either in the form of Demand Draft in favour of Temple officer Mata Shri Chintpurni or through NEFT shall be deposited in the official account of C.T.T . **11283610557, IFSC-SBIN0002327** without which the tender/offer shall be rejected outrightly . - ii) The Earnest Money in the form of FDR/Bank Draft duly pledged to Temple Officer Mata Shri Chintpurni Ji amounting to Rs 05.00 lakh (Rupees Five Lakh

iii) Self-attested copy of GST Registration Certificate & PAN

iv) Criteria, Experience/Past Performance

a. The Bidders shall have to be a legally valid entity, having its registered office in India.(Attach Copy With Technical Bid)

b. The Bidding Companies applying should have at least 05 years of experience in operating Dry fruit Processing & Packing Plant - Please provide requisite evidence along with Technical Bid .

c. The bidder (Authorized supplier / packer) should have regularly for atleast last three years ending 31st March of the previous financial year, packed/ supplied the material mentioned in the NIT with the same or higher specifications as per Annexure-A (supply order to be attached)

v) Capability Equipment & Manufacturing Facilities:-

The bidder must have necessary machinery/equipments for installation of packing of Panch Mewa Parsad Packing Unit.

Vi) Financial Standing under all conditions

a. The average annual financial turnover of The Bidder" during the last five years, ending 31st March of the previous year should be **25 Crores** as per the annual audited balance sheet and profit & loss account of the relevant period duly authenticated by a Chartered Accountant. **Copies of Income Tax Returns for the last five years to be attached (The turnover of the sister concern firms / subsidiaries shall not be considered by C.T.T)**

b. Tender Document duly signed and stamped conforming the acceptance of Terms and Condition mentioned in the NIT

c. Declaration Certificate as enclosed at Annexure – D

d. No Deviation certificate as enclosed at Annexure – E

e. Bidder's details as per Annexure-F

f. The bidder must have its own processing facilities of adequate capacity

g. The bidder should have valid FSSAI Licenses for all its locations- Fresh FSSAI License to be obtained for location allocated by CTT and the unit has to be Certified by an Accredited Rating Agency (copy to be attached)

- h. The bidder should be having own laboratory for testing of raw materials and finished food products and must have qualified OC Team at site. The bidders shall have sufficient ,qualified skilled experienced manpower at its roll (document to be attached).

B. Financial Bid (BoQ)

The minimum reserve percentage share to be quoted is 10 (Ten) percent.

- i) Price bid shall be as per BOQ & has to be submitted on the Format as per Annexure- B) in Financial Bid Envelope.
- ii) The percentage rate quoted should be absolute and unconditional.
- iii) The price bid shall be opened in respect of the bidders who have qualified in the technical bid. Rates are required to be quoted strictly as per prescribed terms and conditions mentioned in the BOQ

Forward Auction

Temple Trust shall be resorting to FORWARD AUCTION (FA) for this tender. FA shall be conducted among the techno- commercially qualified bidders. Price bids of all techno- commercially qualified bidders shall be opened and same shall be considered for FA. In case any bidder (s) do(es) not participate in Forward Auction, their sealed envelope price bid along with applicable loading, if any, shall considered for ranking".

a. **Intent:** To derive maximum benefit in achieving highest income for Temple Trust through competitive biddings.

b. **Start Price:** Start Price for FA shall be highest of sealed envelope price bid.

Note: Wherever more than one highest sealed envelope price bids are identical, the start price shall be declared by increasing the highest sealed envelope price bid by maximum of one increment of 1%.

Forward Auction Process:-

- I). Forward Auction will be conducted if two or more bidders are techno-commercially qualified. In case of two or three qualified bidders, there shall be no elimination of L1 bidder (whose quote is lowest in sealed envelope price

bid). In case of four qualified bidders, the L1 bidder shall be eliminated whereas in case of five qualified bidders, L1 & L2 bidders shall be eliminated. However, in case of six or more qualified bidders are available, FA would be conducted amongst first 50% of the lowest. Number of bidders eligible for participating in FA would be rounded off to next higher integer value if number of qualified bidders is odd (e.g. if 7 bids are qualified, then FA will be conducted amongst four bidders).

II). The Start price for FA shall be highest of sealed envelope % age share price bid. (Note: Wherever more than one highest sealed envelope price bids are identical, then start price shall be declared by increasing the highest sealed envelope price bid by maximum of one increment @ 1 % (One Percent Only)

III). If the start price is higher than the highest sealed envelope price bid, on acceptance of such start price by any bidder this bid would be indicated as current H1 for further bidding. However, if no bidder accepts the start the tender shall be processes accordingly.

iv. In case of no further bidding, FA will be deemed to have been successful with current H1 bidder. Once the FA is done, the ranking status would be based on the last quoted price of the bidder (s) irrespective of the quote received in sealed envelope price bid.

d. Procedure for Forward Auction:

i. Price bids of all techno- commercially qualified bidders shall be opened.

ii. Forward Auction: The bid increment will be @ 1% rupees.

iii. The highest bidder in sealed envelope price bid shall be shown as current H1 and no acceptance of that price is required.

iv Bidders by offering a minimum bid increment or the multiples thereof can displace a standing highest bid and become "H1" and this continues as an interactive process. However, no bidder shall be allowed to increase its bid above the current H1 by more than 5 increments at one go.

v After the completion of the Forward auction, the closing price shall be available for further processing.

REVENUE SHARING :-

The percentage share as quoted in the financial bid of the revenue generated by the selected bidder through the sale of Parsad (through offline or online mode)shall be paid to the Chintpurni Temple Trust by the selected bidder on the 5th of every month for the previous calendar month.

The selected bidder shall submit monthly report for sale of each unit to Temple Trust. The percentage share shall be based on the basic monthly revenue(excluding GST or other taxes).The MIS based software generated report should be submitted to Temple Trust. (in pdf Format).

The percentage share shall remain constant for the entire duration of the contract agreement.

5. RIGHT RESERVED BY Temple Trust Mata Shri Chintpurni Ji

- a. Commissioner(T) -cum Deputy Commissioner Una reserves the right to accept/reject or cancel any tender or all tenders in full or part thereof without assigning any reason.
- b. The C.T.T reserves the right to reject accept or prefer any tender in part or full without assigning any reason whatsoever at any stage.
- c. C.T.T also reserves the right to re-invite the tender at its sole discretion.
- d. The CTT reserve the right to negotiate the quoted rates terms and conditions with the lowest tenderer or any of the other tenderers on quality basis to ascertain the suitability of the acceptable offer.

7. SIGNING OF TENDERS

Each page of the tender (Technical bid) which is to be submitted in physical form tenderer / authorized signatory of the bidder tenderer conforming the acceptance of Terms and Conditions as laid down in the e-NIT document.

8. VALIDITY:

The offer shall remain valid and open for acceptance for a period of 90 days from the date of opening of tenders, if the tenderer withdraws his tender before the expiry of the said period or makes any modifications in the

terms and conditions of the tender. the earnest money/security deposited by the tenderer shall be forfeited without any notice

9. Earnest Money Deposit:

- i) The Bidders shall submit an EMD of Rs. 5,00,000/- in the form of bank Draft/ FDR duly pledged to the Temple Officer Temple Trust Mata Shri Chintpurni Ji.
- ii) EMD shall be submitted along with the Technical Bid only.
- iii) The EMD shall be returned to the unsuccessful Bidder(s) by CTT within 01 month after the placing of the Letter of Award to the successful Bidder
- iv) The EMD of the successful Bidder shall be released after receipt of required security deposit in the form of Bank Guarantee (Security Deposit)

10 Security Deposit/Performance Security :-

(i)The successful Bidders shall furnish security deposit/Performance Security of Rupees 15 Lakh (Fifteen Lakh Rupees Only) bank Draft/ FDR duly pledged to the Temple Officer Temple Trust Mata Shri Chintpurni Ji within a period of 07 Days from the issuance of Letter of Award . Failure to do so within the stipulated period shall make the contract liable for cancellation together with forfeiture of the EMD.

(ii) The validity of Security deposit shall be for the period of agreement plus grace period of 3 months. The security deposit shall be released within a period of 03 months after the satisfactory completion of the Contract.

(iii) In case the contract is further extended, the performance security deposit shall have to be accordingly renewed by the Contractor.

13. General Information/Important Instructions

- i. The supply of Prasad Pouch shall vary as per influx of Pilgrims ranging between 3000 -20,000 per day in the Temple. The Selected bidder should assess the daily Parsad requirement and should ensure enough stock in all the sale outlets accordingly.
- ii. The cost of Tender document shall not be refunded under any circumstances
- iii. The Tender offer shall be valid for 90 days from the date of its submission

- iv. The tenderer are advised to visit the premises identified for the project by the Temple Trust, in advance. This is with a view to ensure that the bidder is well versed with the conditions of the premises, where packing unit is to be installed, before submitting commercial bid.
- v. Tender without requisite fee and not fulfilling all or any of the conditions or submitted incomplete in any respect is liable to be rejected Conditional Tenders shall not be accepted and shall be outrightly rejected.
- vi. The Tender document shall be duly signed and stamped in respect of acceptance of all terms and conditions
- vii. The Bidders shall have to comply with all the statutory provisions as laid down under various Laws/Act/Rules like Employees Provident Fund ESI and other Laws/Acts Rules in force from time to time, and any such as may be enacted in future during the contract period .
- viii. The Bidders shall notify in its bid the details of authorized signatory/ key personnel and their contact details for further communications.
- ix. All the pages of the Tender submitted must be numbered and signed by the authorized signatory
- x. The Bidders shall keep necessary books of accounts and other documents for the purpose of the condition as may be necessary and shall allow inspection of the same by an authorized representative of the CTT and further shall furnish such other information document as required by the representative
- xi. Each Bidder shall submit only one Tender. Submission of any additional Tender shall lead to disqualification
- xii. The CTT reserves the right to reject any or all the bids at any stage without assigning any reason thereof.
- xiii. If any information furnished by the Bidder is found incorrect at the later stage. Contract shall be terminated and further penal action such as forfeiture of Security Deposit debarring for period of three years from participating in CTT tenders etc. shall be initiated
- xiv. Even though any Bidder may satisfy the above requirements it would be liable for disqualification on grounds of misleading or submitting false information or deliberately suppressing the information in the forms statement and enclosures required in the Eligibility criteria document and have record of poor performance such as abandoning work leaving Contract incomplete or financial failures weaknesses etc.
- xv. After scrutiny and evaluation of Financial Bids the Contract will be awarded to the Highest Bidder and the successful Bidder shall have to

xvi. The contract as a whole or part thereof is Non-Transferable

14. Obligations of the Selected Bidder :

- (i) The selected bidder shall be responsible for setting up of plant for packaging at its own cost and only built premises will be provided by the Temple Trust.
- (ii) The selected bidder will not allow or permit his employees to participate in any trade Union activities or agitation in the premises of the owner and the Temple Trust reserves the right to demand change of any employee! worker if need warranted.
- (iii) The selected bidder shall ensure that all safety precautions are properly taken during the process of packaging by its / their employees. Special emphasis will be laid on fire safety norms. Strict compliance is required in this clause and may lead to heavy penalty by the Competent Authority.
- (iv) Maintenance of all civil structure, electrical, plumbing and carpentry in the plant area will be done by the selected bidder during the contract period. The selected bidder shall hand over the premises after the completion of Contract in good condition
- (v) The selected bidder shall appoint fully qualified competent and skilful workers in their services, supervisors and employees workmen at their own cost to ensure that services rendered by them and the responsibility and obligations undertaken by them are carried out to the satisfaction of the CTT.
